ORDER APPOINTING PANEL AND SCHEDULING HEARING


At Wilmington this **7th** day of **April, 2015**:

Having received a Petition for Reinstatement from Jeffrey K. Martin, Esq. (“Martin”), a suspended member of the Bar of this Court (D.I. 13) (“Petition”),

NOW, THEREFORE, IT IS HEREBY ORDERED that:

1. Pursuant to D. Del. LR 83.6(g)(3), the undersigned assigns the Petition to a Panel consisting of the following Judges: Chief Judge Stark, Judge Robinson, and Judge Andrews.
2. The Panel will conduct a hearing to consider the Petition on Tuesday, May 5, 2015 beginning at 1:30 p.m.
3. Martin and the Court’s counsel, Mr. Farnan, shall advise the Court no later than April 28, 2015:
 - a. whether they intend to present any live testimony at the hearing and, if so, from whom;
