Waiving Coverage*			
Employee waives Basic Life Insurance coverage in the first pay period (EOD)	Retroactive to the Enter on Duty (EOD) date. First pay period premium is refunded.		
Employee waives Basic Life Insurance coverage after first pay period (EOD)	Election is effective the last day of the pay period after the election is received by the JBC or the first day in a pay and duty status.		
Newly Hired/Eligible Employees			
Newly Hired/Eligible Employees	Automatically enrolled in Basic coverage effective on employee's EOD date.		
Optional Coverage Enrollment			
Employee elects Optional coverage	Option A and Option B insurance coverage is effective on the first day you are in a pay and duty status on or after the JBC receives your election.		
	Option C insurance coverage is effective on the day the JBC receives your election without regard to pay and duty status.		
Enrollment with Medical Request and OFEGLI Approval			
SF 2822 is approved by OFEGLI	Basic coverage is automatically effective the day after OFEGLI's approval or the first day in a pay and duty status.		
Employee elects Optional coverage	Optional coverage is effective the day after the election is received by the JBC or the first day in a pay and duty status.		
Reducing Coverage*			
Employee reduces Optional coverage	Effective date is the first day of the following pay period after the election is received by the JBC or the first day in a pay and duty status.		
Transfers			
Employee transferring from within the Judiciary Employees transferring from Executive or Legislative Branch	The employee's election remains the same The employee's election from the previous agency is transferred to the Judiciary
