About this statement

Clearing services

Trade date statement

Pricing of securities

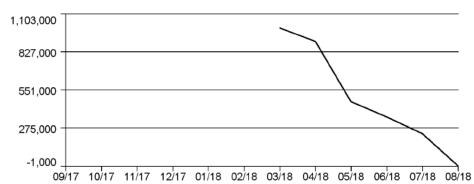

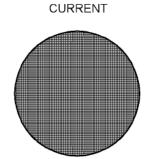
