I. Introduction - Electronic Filing of an Objection to a Presentence Investigation Report

Effective January 6, 2014, the U.S. Probation Office will electronically file the Presentence Investigation Report (PSI) using the Case Managment/Electronic Case Filing (CM/ECF) system. The assigned Judge, prosecutor, and defense attorney will receive the report electronically. Attorneys will have the opportunity to electronically file their objections to the PSI. Instructions for doing so are listed below. For the PSI and any objection, a docket entry will appear but all documents will be restricted from public viewing. Only the assigned Judge, counsel, and probation staff will have access to the documents. Objections to a PSI will be filed through a CM/ECF event entitled "Objection to Presentence Investigation Report".

II. Instructions for Electronic Filing of an Objection to a Presentence Report

1. Access CM/ECF from the Court's website at https://ecf.ded.uscourts.gov. Use the login/password provided by the Court.
