HIGH SCHOOL SUMMER FELLOWSHIP PROGRAM

The United States District Court for the District of Delaware is pleased to announce that it is accepting applications for its High School Summer Fellowship Program for Summer 2018.

Students accepted into this program will work for six weeks, beginning on June 25, 2018 and ending on August 3, 2018. They will work in chambers with Judges of the District Court and/or with other federal employees who work with the Court. The fellows will be paid \$350 per week, or \$2,100 for the six-week program.
